10.Community

Village Green -

We will try and finalise which option we will take regarding the Village Green dispute. It is likely that we will choose to renounce our claim for court expenses in return for Mr Cawood renouncing his claim to drive over the Village Green. PD to check the minutes from July 2010 to March 2017 for any decisions that might have made and voted on then regarding this issue.

D.Hargreaves has managed to source some matching stone for the edging of the south side of The Green. PW has talked to Gary Atkinson at Highways about the issue and will need to submit our plans and get permission to carry out the works. There are some health and safety issues around working on the highway and these will have to be addressed before work can start. We could use the part of the Green that Mr Chandler is currently illegally parking on, to store any building materials. PW to liaise with Highways and D.Hargreaves to address the health and safety concerns.

PW to ask A.Boatwright about the benches that have been removed for renovation.

Traffic and Transport -

PD to write to Highways about a dangerous manhole cover on the grass verge opposite the National Park Information centre.

Maintenance and litter-

There has been a lot of litter in and around the village. NH suggested that we could revisit The Country Code and publicise it on noticeboards and on social media. This could be linked with the meeting with local businesses. CW will discuss it with C.Kilners successor. Local groups such as the WI, the Youth Group etc could organise a litter pick particularly if they were provided with the right equipment. We could also employ another lengthsman to address the problem.
