(a) LAFSC & Brochure

The cheques have been cashed and the bills paid .

P Wherity is to produce a replacement time sheet for A Boatwright.

(b) Village Enhancement Project

- The YDNP would be still happy to help fund the new stone village entry sign. A Bradley is to talk to A Hulme about the design.
- C.Wildman is to meet C.Kilner and Dinsdales are still to meet to discuss the verges and the litter on the approach road.
- NYCC is still to install the sign post.

- We still have some 50% funding available from the LEADER scheme. We can claim £1200 in 2012 and 2013. We have to submit quarterly returns the last of the year to be finalised well before Christmas.
- Following the Malham Parish Meeting it was reported that P Sharp is still keen to plant some fruit trees on part of the Village Green adjacent to his property. I was thought that planting some trees was a good idea but the type and location would need to be discussed by the Parish Council if we were to be involved in funding.
- C Wildman is to approach C Kilner to discuss the placing of some "woodland walk" signs at the entrance to the plantation.

(c) P Wherity has organised the evidence needed to register the Parish Land and the solicitor is preparing a statement for our approval. P Wherity is to place a notice on the village board to inform residents that this is taking place .

(d) Traffic and transport

The ice cream van is still parking illegally in Malham and causing the customers to queue across the road in a hazardous way.

(e) The Queen's Jubilee

Donations are required to help pay for the Jubilee mugs to be presented to the pupils at KM School.

The marquee for the picnic is to be erected on the field behind the Village Hall.

The Beacon on Kirkby Fell is to be registered and will be listed in The Queen's book.

10. Correspondence

A request for permission to erect a marquee outside the Lister's on The Green was approved subject to them donating to the Safari Fund.

It was noted that some debris had blown out of the Lister's skip and into the river.
