Kirkby Lonsdale Coaches who run the Saturday bus service 75. will not be able to continue the service and have given 10 week's notice. NYCC have been informed and we are awaiting their response.

There have been reports of cars speeding through Kirkby Malham. MH to report to Highways.

## **National Trust Update**

The roof on Tarn House is being repaired and litter picking is in progress.

We were asked to report any anti-social behaviour or illegal parking to the police in the first instance.

The NT are considering opening Town Head Barn and invite suggestions about how to manage it.

#### **YDNPA Update**

Rob Ashford gave us his annual report. He is taking up a new post at the end of May. We wish him well and thanked him for all his hard work. YDNP will continue to provide 2 seasonal rangers from July-Sept. to help with visitor management in the Craven area of the National Park. The Malham access improvement project has been completed and the NP would like to thank all Landowners/tenant farmers who have given permission to change the gates for access across their land. There has been a downturn in visitor numbers using the NP Visitor centre over the last few years (although school group numbers have increased) There are plans to redesign The Centre.
