National Trust Update

Apologies given by Jess Darwin. Her colleague, Rachel Forsyth, Countryside Manager at National Trust (Yorkshire Dales) attended the meeting in JD's absence and provided a useful update to KMPC.

11th June email from Martin Davies providing an update that Tarn House is being marketed with Savills agents for tenant opportunities.

Also extended invitation to KMPC Councillors to visit Tarn House and meet him and the team and help connect between NT and KMPC.

Rachel extended this offer and discussed potential day/date for Councillors to visit. DH asked that there should be more factual discussion about the 'plans' the NT have and to share this more openly with KMPC. RF confirmed that Tarn House could never be sold by NT.

NT local team are occupying North Wing at Tarn House as their office/base.

RF advised that works on sluice gates at Malham reservoir is going ahead to protect Malham Village from flood risk. RF confirmed that there was no news on future options to use Town Head barn.

YDNPA Update

Ahead of the July '24 KMPC meeting Kate Hilditch, Area Manager (Southern Dales) provided confirmation (via email) that a new Area Ranger – <u>Will Locke</u> – has been appointed to our area and he will begin this role as part of the Western Ranger Team in August '24. Will Locke is already working for the YDNPA.

KH also confirmed that footpath repair work at the Scalegill Mill Leat Path will be undertaken in July '24.
